Ringkasan Eksekutif Executive Summary

The Year of Digital Transformation

Tahun 2020 adalah “tahun pandemi” sehingga fokus organisasi adalah bertahan, berkembang dan berupaya mencapai target organisasi untuk menyongsong transformasi organisasi 2021-2025. Tahun 2020 penuh dengan tantangan dan ketidakpastian dimana dunia dihadapkan dengan situasi Pandemi Covid-19. Kondisi ini menjadi pengalaman baru bagi PRAKARSA dalam beradaptasi dan bertransformasi secara cepat. Apresiasi perlu diberikan karena telah berhasil melewati tantangan bersama. PRAKARSA berupaya melakukan transisi dalam pelaksanaan seluruh kegiatan dengan memanfaatkan teknologi digital. Perubahan situasi ini memaksa kita lebih inovatif, adaptif dan kolaboratif untuk melakukan kerja-kerja yang berkontribusi kepada masyarakat.

Greetings,

Tahun 2020 adalah tahun pandemi Covid-19 dan tahun “transformasi digital”. Sungguh tahun yang sangat berat bagi semua, tidak terkecuali bagi PRAKARSA. Di tengah situasi pandemi Covid-19 yang sulit ini, kami menempatkan kesehatan-keselamatan staf dan keluarganya sebagai prioritas utama. Untuk itu, sejak Maret 2020 kami bekerja dari rumah dan menunda beberapa kegiatan lapangan. Suatu kondisi yang sangat menantang dan kami harus melakukan adaptasi secara cepat dan tepat.

2020 turned out to be the year of the COVID-19 pandemic and the year of “digital transformation”. It has been such a very challenging year for all, including PRAKARSA. Amid this difficult pandemic situation, we prioritize the health and safety of our staff and their families. Thus, we have been working from home and postponing some field activities since 2020. This challenging condition requires us to adapt rapidly and appropriately.

Pandemi Covid-19 telah memaksa kami melakukan percepatan adaptasi dan inovasi pada semua aspek. Kerja-kerja organisasi harus tetap optimal dan semakin kontributif bagi publik, namun kesehatan-keselamatan staf dan keluarganya harus kami prioritaskan. Teknologi informasi sangat membantu pelaksanaan kerja-kerja kami dan pandemi telah memaksa kami untuk melakukan transformasi digital, mengakselerasi teleworking. Agar semua staf dapat beradaptasi secara mudah dan sehat, maka kami memastikan “right to connect” dan “right to disconnect” dapat berjalan secara seimbang.

The COVID-19 pandemic has forced us to accelerate adaptation and innovation in all aspects. The organization’s work should remain optimal and contribute more to the public. However, we should also prioritize the health and safety of our staff and their families. Information technology is beneficial for our work, and the pandemic has pushed us to implement digital transformation to accelerate teleworking. We ensure that the “right to connect” and the “right to disconnect” can run in a balanced way so that all staff can adjust swiftly and healthily.

Kami mengakui bahwa beberapa program dan riset tidak berjalan sesuai dengan time-line yang ada. Maka, kami perlu menyampaikan terima kasih kepada donor dan mitra kerja yang telah memberikan pengertiannya. Saya perlu menyampaikan apresiasi setinggi-tingginya kepada seluruh staf yang telah berhasil melewati tantangan dan transformasi digital ini dengan cukup baik. Terima kasih juga kepada badan pengurus PRAKARSA atas bimbingan dan dukungannya.

Dalam upaya pencegahan dan penanganan pandemi Covid-19, kami mempunyai komitmen untuk turut berkontribusi bagi publik secara luas. PRAKARSA bekerja sama dengan Gusdurian Peduli dan Oxfam di Indonesia untuk melakukan pendistribusian 1700 hygiene-kit kepada masyarakat luas di wilayah Jabodetabek. Selain itu, kami selalu mendukung lingkungan Rukun Tetangga/Rukun Warga di sekitar kantor PRAKARSA dalam pencegahan dan penanganan Covid-19 dengan membagi hygiene-kit, vitamin dan dukungan lainnya kepada warga yang terkena Covid-19.

Dalam konteks kebijakan, kami aktif membangun inisiatif bersama organisasi masyarakat sipil untuk mendorong pemenuhan hak-hak sosial ekonomi warga di masa pandemi. Beberapa kegiatan antara lain melakukan mengusulkan pemberian bantuan tunai, mengusulkan skema universal basic-income (UBI), pemantauan pelaksanaan bantuan tunai dan sharing experiences di tingkat lokal atau komunitas tentang pencegahan dan penanganan dampak pandemi Covid-19.

Secara umum, 2020 merupakan tahun “bertahan dan berjuang” untuk mencapai target organisasi secara optimal sebagai modalitas dalam menyongsong transformasi organisasi 2021-2025 sebagaimana tertuang dalam Rencana Strategis PRAKARSA 2021-2025.

Meskipun situasi sulit, namun kami dapat mencapai beberapa keberhasilan antara lain resilien di tengah pandemi, menambah staf, mendapatkan penambahan program baru dan mampu menyelesaikan beberapa proyek tepat waktu. Beberapa program baru yang kami kerjakan yakni: (i) Ford Foundation untuk proyek “pengembangan kolaborasi multipihak dalam penguatan reformasi kebijakan fiskal di sektor ekstraktif, perkebunan dan kelautan” (2020-2021); (ii) Asesmen tentang “Decarbonizing Indonesian Economy: Assessing International Financial Institutions Involvement in Accelerating Energy Transitions” yang didukung oleh European Climate Foundation / TARA

We acknowledge that some programs and research do not follow the timeline. Therefore, we would like to express our gratitude to our donors and partners for their understanding and all staff who have successfully managed this difficulty and digital transformation. Besides, we are also very grateful to the PRAKARSA’s Board of Governors for their guidance and support.

We are committed to assisting the broader public in preventing and responding to the COVID-19 pandemic. PRAKARSA has collaborated with Gusdurian Peduli and Oxfam in Indonesia to distribute 1700 hygiene kits to the wider community in the Greater Jakarta area. In addition, we supported the neighborhood/community associations around the PRAKARSA office in preventing and handling COVID-19 by distributing hygiene kits, vitamins, and other support to citizens affected by the outbreak.

In the policy context, we actively built initiatives with civil society organizations to encourage the fulfillment of the socio-economic rights of citizens during the pandemic. Some of the activities we carried out included proposing cash transfers, proposing a universal basic-income (UBI) scheme, monitoring the implementation of cash transfers, and sharing experiences at the regional level on preventing and handling the impact of the COVID-19 pandemic.

In general, 2020 was a year of “surviving and struggling” to optimally achieve organizational targets as a modality in welcoming the 2021-2025 organizational transformation as stated in the 2021-2025 PRAKARSA Strategic Plan.

Despite the challenging situation, we successfully achieved resilience during the pandemic, recruited staff, added new programs, and accomplished several projects on time. Some of the new programs we worked on included: (i) the Ford Foundation for the “development of multi-stakeholder collaboration in strengthening fiscal policy reforms in the extractive, plantation, and marine sectors” project (2020-2021); (ii) an assessment of “Decarbonizing the Indonesian Economy: Assessing International Financial Institutions Involvement in Accelerating Energy Transitions” supported by the European Climate Foundation/TARA Foundation (September 2020 – August 2021); (iii) the Ministry of Research and Technology/the National Research and Innovation Agency in the 2020-2024 National Research Priority Program (PRN); (iv) the Ministry of Manpower in monitoring Community Vocational Training Centers; (v) the Ministry of Foreign Affairs

Foundation (September 2020 – Agustus 2021); (iii) Kemenristek-BRIN dalam program Prioritas Riset Nasional (PRN) 2020-2024; (iv) Kementerian Ketenagakerjaan dalam monitoring Balai Latihan Kerja Komunitas; (v) Kementerian Luar Negeri dalam penyusunan draft Rencana Aksi Nasional GCM/Global Compact for Safe, Orderly and Regular Migration (November-Desember 2020); (vi) International Budget Partnership dalam program kajian dan kampanye Universal Basic Income; (vii) World Resources Institute dan UKCCU untuk isu green economy (Nov 2020 – Mei 2021); (viii) Riset kolaboratif dengan Vietnam Institute for Economic and Policy Research (VEPR), Vietnam Alliance for Tax Justice (VATJ) dan Oxfam Vietnam tentang FDI dan Perpajakan di ASEAN.

We succeeded in initiating the formation of new networks at the national level, i.e., the Coalition of Universal Basic Income (JAMESTA) and the Community Coalition Care for Elderly (KuMMPUL).

On behalf of PRAKARSA's board of governors, staff, associates, and advisory board, I, as the Executive Director, present the 2020 Annual Report to the public. The 2020 PRAKARSA annual report serves as one of our consistent efforts in realizing transparency and public accountability. This annual report presents various summaries of PRAKARSA's activities, achievements, and finance throughout 2020. We expect that stakeholders' trust in PRAKARSA will increase through this report.

Jaminan sosial yang inklusif sangat penting. Ia salah satu kunci ketahanan ekonomi dan sosial warga negara. Menghadapi ketidakpastian dunia, jaminan sosial memastikan warga mendapat penghidupan dan pekerjaan yang layak. Namun demikian, Indonesia tak bisa latah. Sekedar ikut-ikutan negara lain yang kondisinya pasti berbeda. Diperlukan riset dan kajian mendalam agar Indonesia memiliki konsep, formula dan implementasi program jaminan sosial yang tepat, selaras dengan kondisi objektif sosio-ekonomi dan sosio-politik negara bangsa tercinta.

Pada titik ini, sebagai NGO yang berfokus pada isu-isu welfare policies, PRAKARSA menemukan peran strategisnya. Riset dan kajian PRAKARSA sebelumnya telah mempertajam kebijakan sosial nasional yang berproses menuju kematangan. Kita tahu, kebijakan dan program jaminan sosial memang tidak bisa sekali jadi. dan khas, tetapi dengan ekonomi yang masih menengah. Diperlukan riset, kajian dan monitoring yang kuat guna mematangkan kebijakan dan program jaminan sosial nasional, termasuk inisiatif-inisiatif progresif baru yang dapat menjamin kelangsungan hidup semua warga negara tanpa kecuali

Inclusive social security is crucial. It serves as one of the keys to the economic and social resilience of the citizens. Social security ensures that citizens obtain a decent life and work in dealing with global uncertainty. However, Indonesia should not merely follow the trend or copy-paste other countries whose conditions are definitely different. In-depth research and studies are necessary; thus, Indonesia can build the proper concept, formula, and implementation of social security programs in line with our beloved nation's objective socio-economic and socio-political conditions.

At this point, as an NGO focusing on welfare policy issues, PRAKARSA has discovered its strategic roles. PRAKARSA's previous research and studies have sharpened national social policies progressing towards maturity. We know that social security policies and programs cannot be executed instantly. Moreover, in the context of Indonesia, despite its large and unique country, it remains classified as a middle-income country. Strong research, studies, and monitoring are required to finalize national social security policies and programs, including new progressive initiatives that can ensure citizens' life sustainability inclusively

Dialog Koalisi Ketenagakerjaan dengan Kementerian Ketenagakerjaan

Dialogue of the Manpower Coalition with the Ministry of Manpower

Koalisi Ketenagakerjaan mendapatkan kesempatan melakukan pembicaraan kebijakan dengan Menteri Ketenagakerjaan Republik Indonesia dan jajarannya. Selain memperkenalkan Koalisi Ketenagakerjaan kepada Menteri Ida Fauziyah, dialog kali ini juga bertujuan memperkuat kolaborasi dengan think-tank, organisasi masyarakat, serikat buruh dan akademisi. Selain itu, pertemuan ini diharapkan bisa memperkuat best-practices pelatihan vokasi, perlindungan pekerja baik yang di dalam negeri maupun pekerja migran, melakukan percepatan reformasi kebijakan ketenagakerjaan yang melindungi tenaga kerja, mengedepankan pendekatan ekonomi inklusif dalam perumusan RUU Cipta Lapangan Kerja dan lain-lain.

The Manpower Coalition had the opportunity to conduct policy talks with the Minister of Manpower of the Republic of Indonesia and the staff. Apart from introducing the Manpower Coalition to the Minister, Ida Fauziyah, the dialogue was also aimed to strengthen the collaboration with think-tanks, community organizations, labor unions, and academics. In addition, this policy talks meeting was expected to strengthen vocational training best-practices, protect domestic and migrant workers, accelerate labor policy reforms protecting workers, promote an inclusive economic approach in the Job Creation Bill, and others.



Dialog Strategi Komunikasi RUU KUP dengan Direktorat Jendral Pajak

Dialogue on the Communication Strategy of the KUP Bill with the Directorate General of Taxes (DGT)

Dalam pertemuan ini didiskusikan mengenai strategi komunikasi RUU Ketentuan Umum dan Tata Cara Perpajakan (RUU KUP) yang menjadi pertimbangan tindak lanjut DJP untuk mensosialisasikan RUU KUP di masyarakat. Prakarsa Bersama Forum Pajak Berkeadilan memberikan masukan ke DJP terkait dengan update isu perpajakan di masyarakat dan sekaligus memberikan input strategi komunikasi RUU KUP.

This meeting discussed the communication strategy concerning the Draft of Law on General Provisions and Tax Procedures (KUP Bill), serving as the follow-up consideration for the DGT to disseminate the KUP Bill to the community. In collaboration with Justice Tax Forum, PRAKARSA suggested inputs regarding tax issues updates in the society to the DGT and communication strategies for KUP Bill.

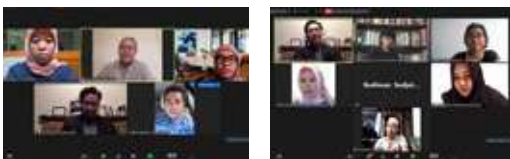
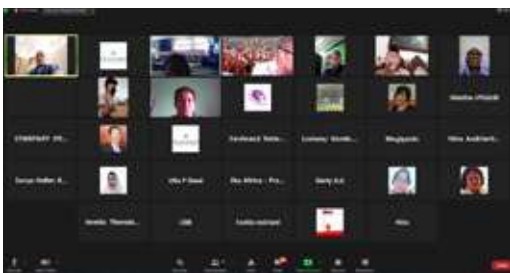
PRAKARSA has built a multi-stakeholder dialogue platform to discuss how the low financial literacy behind high financial inclusion has trapped consumers into debt bondage through online loans or credit cards. Insufficient consumer protection efforts further worsen this condition. In other ways, PRAKARSA also identified how debt bondage could impact the macro-economy and potentially disrupt financial stability, especially amid the COVID-19 pandemic. This meeting was attended by national and global networks, i.e., Otaviano Canuto as the Senior Fellow at the Brookings Institution, Gustavo Machado de Melo as the Researcher at the Idec Fair Finance Guide (FFGI), Brazil, Kuseryansyah as the Executive Director of Indonesian Joint Funding Fintech Association (AFPI), and Tulus Abadi as the Chairman of Indonesian Consumers Foundation (YLKI).

Expanding social protection in Indonesia amidst the COVID-19 Pandemic

PRAKARSA mendorong perluasan perlindungan sosial kepada kelompok rentan salah satunya lansia. PRAKARSA memproduksi dua riset dan mendapatkan rekognisi dari pemerintah, organisasi masyarakat sipil dan swasta atas perhatiannya terhadap isu kelanjutusiaan.

PRAKARSA encouraged the expansion of social protection to vulnerable groups, one of which is the elderly. PRAKARSA conducted two studies and received recognition from the Government, civil society organizations, and private sectors for their attention to elderly-related issues.

Besides, PRAKARSA conducted a study related to the MSMEs portrait during the COVID-19 pandemic.
